INFORMAL SUMMARY OF THE SIXTEENTH MEETING

A. OBJECTIVES AND PARTICIPATING AGENCIES

- 1. The Sixteenth Meeting of the United Nations Interagency Task Force on the Prevention and Control of Non-Communicable Diseases was held by videoconference on 16-18 March 2021. Twentynine Task Force members participated as well as the UN Multi-Partner Trust Fund Office. The World Health Organization and the International Atomic Energy Agency co-chaired the meeting. The agenda is Annex 1 (which includes links to the background papers²), and the list of participants is Annex 2.
- 2. The main objectives of the meeting were (i) to review progress since the Fifteenth Task Force Meeting (3-5 November 2020); (ii) to update on a range of joint programmes and other workstreams, including tobacco control to identify opportunities for further interagency collaboration; (iii) to discuss opportunities to scale up multisectoral support to countries in the context of the COVID-19 pandemic, including mobilizing resources for the NCD and Mental Health Multi-Partner Trust Fund; and (iv) to review the recent evaluation of the work of the Task Force.

B. REVIEW OF THE SUMMARY OF THE FIFTEENTH MEETING AND UPDATE ON GLOBAL EVENTS AND ASSIGNMENTS

- 3. Members reviewed the summary of the Fifteenth Task Force Meeting and noted that progress has been made across the majority of agreed actions. Participants noted the opportunity to provide feedback with regard to the WHO options paper on the WHO Global Coordination Mechanism on NCDs.
- 4. The Task Force received an update from WHO on global events and assignments since the Fifteenth Meeting.

Actions

B1. Complete outstanding actions from 15th Task Force Meeting:

- Continue with United Nations country team interviews on integrating NCDs and mental health in UN planning frameworks with an analysis of results.
- Continue to work with the UN Development Coordination Office on opportunities to include NCDs and mental health into country level UN planning guidance.

B2. Agencies to continue to share technical tools and publications for inclusion on the Task Force webpages.

B3. Agencies to review and provide comments on the WHO/GCM Options paper.

C. NCDs AND COVID-19

- 5. UN COVID-19 specific planning instruments such as COVID-19 socio-economic response plans (SERPs) are gradually being incorporated and aligned with broader UN planning frameworks such as the UN Sustainable Development Cooperation Frameworks (UNDCFs). Ensuring NCDs are reflected in this process was recognized as critical to building back better. The focus of the SDG3+ Global Action Plan determinants of health accelerator is now around COVID-19 vaccination equity in the context of broader response and recovery.
- 6. Participants provided updates on their work and identified future entry points for further action. It was agreed that 'Responding to NCDs during and beyond the COVID-19 pandemic: examples of actions', should be reviewed and updated. Participants agreed that there remains the need for better dissemination of broader issues around NCDs, COVID-19 and development frameworks as updated guidance on planning emerges from the UN Development Coordination Office.

Actions

- C1. Task Force to work closely with the UN Development Coordination Office on the changing landscape with regards to COVID-19 planning (SERPs, humanitarian plans) and how they are being aligned with UNSDCFs to identify future entry points for NCDs and actions that the Task Force can take to ensure NCD prevention and control, including the implementation of the WHO FCTC, is a key part of countries' efforts to build back better.
- C2. Once guidance is received from the UN Development Coordination Office, develop and deliver a set of webinars for UN country teams and whole-of-government audiences on NCDs as part of building back better, with the initial focus on countries where the Task Force has been operational (Task Force Secretariat and interested Members).
- C3. Agency actions under the Task Force COVID-19 NCD paper to be updated to include review of actions, lessons learnt, future actions for COVID-19, including implications for future pandemics.

D. TOBACCO CONTROL

- 7. WHO provided an overview of the latest evidence linking tobacco use to higher susceptibility to and more severe outcomes from COVID-19 infection. Members discussed opportunities to strengthen the tobacco control response, in line with the tobacco cessation initiatives proposed within the WHO-led year-long campaign to help 100 million people quit tobacco.
- 8. An update on progress of tobacco-related activities was provided, including the Alternative Livelihood for Tobacco Farmers initiative, which is expected to pilot its advocacy toolkit in selected countries by the end of 2021. Members discussed opportunities to get all UN campuses smoke-free and to take greater action to stop tobacco industry interference in line with the UN Model Policy.

9. WHO and the Convention Secretariat consulted Task Force Members on the opportunity to establish and join a workstream on tobacco and child development, and a workstream on the implementation of the Protocol to Eliminate Illicit Trade of Tobacco.

Actions

Alternative livelihood for tobacco farmers

D1. Draft toolkit to be shared with all agencies in the thematic group in mid-April 2021 for feedback and consolidation. Once finalized, toolkit to be piloted in a few countries. (Tobacco thematic group)

Model Policy and Smoke-free UN

- D2. Convention Secretariat to set up bilateral calls with all members of the task force to understand how to best move forward with implementing the <u>UN Model Policy</u>. The Convention Secretariat will resend the survey. In the meantime, Task Force Members are reminded to respond to the survey on implementing the Model Policy.
- D3. High-level interagency group to be established to encourage agencies to implement 100% smoke-free UN campuses as soon as possible, in the first instance developing a mutually agreed time bound action plan. In support of this, map where individual agencies are with regards to implementing smoke-free campuses and the political and technical support that they require for implementation. (Task Force Secretariat, WHO and Convention Secretariat)
- D4. Solicit support from the UN High-Level Committee on Management for 100% smoke free UN campuses and full observation of the UN Model Policy, in line with the August 2019 UN Secretary-General memo. (WHO, Convention Secretariat, Task Force Secretariat)
- D5. Hold a side event on <u>smoke free UN campuses and the UN Model Policy</u> during the 2021 ECOSOC High-level Political Forum on Sustainable Development. (Convention Secretariat, Task Force Secretariat, WHO, other interested members of the Task Force)

Tobacco-free schools

D6. Scale up implementation of the Tobacco-free schools guide. (Tobacco thematic group, UNICEF)

Tobacco and child development

D7. Continue to promote a workstream on tobacco and child development. (Tobacco thematic group)

Implementation of the Protocol to Eliminate Illicit Trade in Tobacco Products

D8. Establish a workstream on Implementation of the Protocol and invite interested members to join the workstream. (Tobacco thematic group, UNODC)

Access Initiative for Quitting Tobacco (AIQT)

D9. Task Force Members to take note of the tobacco & COVID-19 risks, and consider joining forces with WHO, PATH and the Task Force Secretariat to support and scale up the year-long campaign on tobacco cessation, including World No Tobacco Day on 31 May 2021. (All)

COP9 (8–13 November 2021) and MOP2 (15–17 November 2021)

D10. Task Force Members to register for the Conference of Parties and Meeting of Parties where they are already observers. Those that are not yet observers to either or both are encouraged to apply for observer status before 15 August 2021. (All)

E. UPDATE ON SELECTED JOINT PROGRAMMES AND INITIATIVES, INCLUDING REPORT BACK FROM AGENCIES WORKING ON NCDS, LAW AND HUMAN RIGHTS

10. Updates were received from the following joint programmes and initiatives that Task Force members are working on: (i) NCD 2030; (ii) SAFER; (iii) the Health Environment and Climate Change Coalition (HECCC); and (iv) NCDs, law and human rights, including the WHO-IDLO Global RECAP. Progress on each of these, along with other joint programmes and initiatives has been included in this year's report to ECOSOC.

Actions

E1. Joint programmes and initiatives to continue their activities, reaching out to other agencies as required and report back to the 17th meeting.

F. UN NUTRITION

- 11. The Chair of UN Nutrition, Dr Naoko Yamamoto, described the recently established interagency coordination and collaborative mechanism for nutrition at global and country levels, which resulted from the merger of the UN Network of the Scaling Up Nutrition Movement and the UN System Standing Committee on Nutrition. FAO hosts the Secretariat for UN Nutrition, which includes staff seconded from UNICEF and WFP, and the UN-REACH team. The 2021 workplan and 5-year strategy are being finalized. Two upcoming events were described: (i) the UN Food System Summit (pre-summit Rome, 26-28 July 2021, Summit New York, September 2021); and (ii) the Tokyo Nutrition for Growth Summit 2021 (December 2021).
- 12. The UN Nutrition Secretariat, on behalf of the Task Force Thematic Group Nutrition and NCDs, provided an update on progress made by the Group. Participants described opportunities for supporting countries scale up actions on Nutrition.

Actions

- F1. UN Nutrition and TWG on Nutrition and NCDs to structure its work and align its activities with the four priority activities of UN Nutrition's workplan.³
- F2. As part of F1, UN Nutrition and TWG on Nutrition and NCDs to work with the investment case component of the WHO-UNDP joint programme to develop this work at country level.
- F3. As part of F1, UN Nutrition and TWG on Nutrition and NCDs to identify examples of successful country action including investment cases for the Tokyo Nutrition for Growth Summit 2021.

G. MULTI-PARTNER TRUST FUND

13. The Task Force Secretariat described progress, including that WHO, UNDP, UNICEF and the MPTF Office were in the process of signing the Memorandum of Understanding. The critical next step was to mobilize resources. The Task Force Secretariat has received funds to employ two consultants

to support the work of the MPTF Secretariat, the first for mobilizing resources, the second on policy and strategy.

- 14. The UNDP Multi-Partner Trust Fund Office in New York provided an overview on mobilization resources for MPTFs and the role of innovative financing. The WHO Resource Mobilization Department described strategies for donor engagement, including seizing the opportunity presented by COVID-19.
- 15. Task Force members discussed approaches to successfully engage with potential donors for the MPTF, including learning from the experience of other organizations. Agencies expressed interest in joining forces with the MPTF.

Actions

- G1. Task Force Members to work with development partners, civil society and the private sector to mobilize resources for the Trust Fund, while giving due regard to managing conflicts of interest, including through establishing a resource mobilization group. (Task Force Secretariat, WHO, UNICEF, UNDP)
- G2. MPTF Secretariat to learn from the experience of TB Reach and Access Accelerated.
- G3. Task Force members that wish to join the MPTF as a PUNO (Participating UN Organization) to inform the MPTF Secretariat. MPTF Secretariat to circulate UNDG guidance on PUNOs.

H. NCDs AND THE GLOBAL FUND

- 16. WHO presented three asks that it is making of the Global Fund: (i) WHO and the Global Fund to conduct a feasibility study for a potential evolvement of the existing country funding model of the Global Fund by also addressing co-morbidity and mortality rates from NCDs; (ii) WHO and the Global Fund to develop an innovative partnership for chronic care of HIV, TB and NCDs; and (ii) WHO and the Global Fund to develop a joint project to help countries restore disrupted health services for HIV, TB, malaria and NCDs and recover from the deadly interplay. Task Force members were reminded that the Global Fund had a policy for supporting co-infections and co-morbidities⁴ but that countries were not making the most of it.
- 17. Participants welcomed the proposal from WHO for the Task Force to step up its advocacy to encourage greater support on NCDs from the Global Fund.

Actions

H1. Establish a work stream to explore country level understanding of comorbidities with a view to advocating and building the case at country level for Global Fund applications to include NCDs. (Task Force Secretariat, Global Fund, WHO, UNAIDS, UNICEF, UNDP, UNFPA, FCTC Secretariat)

I. SMALL ISLAND DEVELOPING STATES (SIDS) SUMMIT FOR HEALTH

18. WHO described three top strategic priorities for action in Small Island Developing States (SIDS): climate change, NCDs and malnutrition and COVID-19 response and recovery — all of which are relevant for the Task Force, alongside recent activities to drive forward political, technical actions as well as mobilizing resources. A roadmap leading up to the SIDS Summit for Health, 28-29 June 2021 was shared, along with a possible ministerial meeting on NCDs in 2022 and follow up health summit in 2023. The 2021 Summit would provide a call to action and strengthen financial and implementation partnerships.

Actions

I1. Task Force Secretariat and WHO to work with Task Force Members to provide examples of joint action on NCDs and mental health (including linkages with COVID-19) in SIDS for promotion in the SIDS Summit, 28-29 June 2021 and follow-up actions in SIDS. (Task Force Secretariat, WHO)

J. TASK FORCE AWARDS

- 19. Task Force Members noted details and the timeline for this year's awards. In line with discussions at the Fifteenth Meeting, the call for nominations encourages proposals that highlight action: (i) taken by children and youth groups as well as those working with minority communities; and (ii) on the NCD-related SDGs during the COVID-19 pandemic.
- 20. The Task Force Secretariat encouraged agencies to: (i) disseminate the call, in particular highlighting the importance of getting nominations from ministries and government agencies outside health; and (ii) join the selection committee.

Actions

- J1. Agencies to promote the 2021 awards and identify nominations, especially focusing on non-health sectors, and encouraging nominations that highlight action taken by children and youth groups as well as those working with minority communities, and action on the NCD-related SDGs during the COVID-19 pandemic.
- J2. Agencies to nominate themselves to serve on the awards panel.

K. MID-POINT EVALUATION OF THE IMPLEMENTATION OF THE WHO NCD GLOBAL ACTION PLAN, INCLUDING IMPLICATIONS FOR THE WORK OF THE TASK FORCE AND UPDATING THE TASK FORCE STRATEGY 2019-2021

21. The mid-point evaluation of the WHO NCD Global Action Plan included a review of the work of the Task Force. The consultants that undertook the evaluation presented their work, including a standalone report on the work of the Task Force for the benefit of Task Force members. A summary briefing paper on the evaluation is available on the Task Force webpages.⁵

22. Task Force Members welcomed the positive feedback on its work and discussed the findings of the report and implications for its future work. Task Force members agreed that the findings should be used to support the development of the next Task Force strategy.

Actions

- K1. Building on joint programming missions and further discussions with UNDCO, develop and start implementing a strategy for stepping up discussions, engagement and a package of support with and for UN country teams and governments on NCDs.
- K2. Task Force focal points to ensure that discussions and decisions from Task Force meeting are reported back to their senior management in order to build even greater support for the work of the Task Force.
- K3. Task Force Secretariat to support Members include NCDs and mental health in governing body and senior management discussions as and when appropriate.
- K4. Task Force Secretariat to work with members to develop the successor to the 2019-2021 strategy for review at the 17th Task Force meeting, building on the findings of the mid-point evaluation.

L. ECOSOC 2021 REPORT – CURRENT STATUS AND HEADLINE MESSAGES

23. Comments from Task Force Members on the draft report on the work of the Task Force had been integrated into the final version, which had been submitted to UN DESA on 17 March 2021. Task Force Members were reminded of the key messages in the report.

M. DATES AND VENUES FOR FUTURE TASK FORCE MEETINGS

24. It was agreed that the 17th meeting would be in the autumn. Participants agreed that once the COVID-19 situation allows for face to face meetings, the Task Force should move to alternate virtual and face-to-face meetings.

Actions

M1. Identify a co-host for the autumn 2021 meeting of the Task Force, which logistics to be determined by the COVID-19 situation. (Task Force Secretariat)
