Breaking down barriers

Who we are

We are a not-for-profit G20 & G7 advocacy initiative founded during the German G20 Presidency in 2017. Over the last 7 years, we have increased our collaboration with both the G20&G7 Presidencies to reflect the need for increased convergence and stronger multilateral agendas in times of multipolar challenges. We represent a unique group of 30+ global health and multilateral organizations, uniting behind a shared vision to tackle current and future global health challenges (UN SDG 3) through cross-sectorial Partnerships (UN SDG 17). **We turn your differences into common objectives that leave no one behind!**

What we do

We aim to tackle the growing global burden of communicable and non-communicable diseases by promoting the delivery of the United Nations Sustainable Development Goals (UN SDGs), by 2030 with a focus on SDG 3 “Health and well-being for all” and SDG 17 “strengthening partnerships.” We identify and highlight the interdependency of disease areas and their link to global challenges such as climate change, security, and economic constraints to the highest levels of G20 & G7 policymaking. Building stronger convergence of G7 and G20 communiques and agendas, especially

in times of multipolar crisis, lies at the heart of our mission. We aim to raise the issue of innovation in global health and development, and sustainable financing to the highest levels of policy-making in G7 and G20+ fora. By promoting inclusive partnerships, we make your voice heard. Partners work together with the G20 & G7 HDP Secretariat to provide recommendations through five subgroups: antimicrobial resistance; pandemic preparedness and response; sustainable financing; digital health and women’s health. Partners are nominated by peers to Chair, or Co-Chair, the subgroups.

Why we are needed

Traditionally, global health organizations operated in disease silos - advocating for their specific disease interest, struggling to get the attention of policymakers. By bringing together a cross-sectoral group of partners, we break down barriers to help provide a stronger advocacy message across diseases for our Partners directly to policymakers. By highlighting innovative and blended finance mechanisms in health and providing evidence-based, bottom-up and top-down policy recommendations we aim to effectively tackle global health issues and advance the role of prevention for sustainable health systems beyond 2030.

Achievements

Our work is supported by a network of high-profile Partners, Global Ambassadors and Parliamentary Council from across the globe, with backgrounds in politics, philanthropy, international organisations,



One message, one voice

We have successfully advocated for significant advancements in the multilateral fora, including the establishment of the G20 Joint Finance and Health Task Force. In 2023, we have been nominated as Advisory and Advocacy Partners for the G7 Impact Investment Initiative, hosted a dialogue on digital health at the request of the G20 Indian Presidency, and a dialogue on UHC at the request of the G7 Hiroshima Health Task Force. We have consistently engaged our partners with the official G20 and G7 delegations, through attending the Ministerial meetings as official delegates, closed-door policy roundtables, and integrating partners as technical experts.

Our cross-lateral approach to global health issues, combined with our unique positioning, has allowed us and our partners to effectively advocate for policy change at the highest political level.

Every year we submit recommendations directly to G20 and G7 Finance and Health Ministers, and Sherpas, contributing to the G20 and G7 policy processes. Through our sub-groups, our partners reach convergence to maximise advocacy outputs. The outcome is an effective shaping of G20 and G7 policy objectives.

Building stronger convergence of G7 and G20 communiques and agendas, especially in times of multipolar crisis, lies at the heart of our mission. By highlighting innovative and blended finance mechanisms in health and providing evidence-based, bottom-up and top-down policy recommendations to tackle global health challenges long-term, we aim to safeguard vulnerable populations and especially women and children against emerging, infectious, and non-communicable diseases.



Seeing health as a sustainable investment

Closing the Health Financing Gap

It's estimated that financing the achievement of the SDGs by 2030 will require an additional US\$ 30 trillion in investments (Source G20HLIP) over the next decade. Significant financial resources will be necessary to reach these targets as funding by philanthropy (US\$ 150 billion annually) and governments in OECD countries (10 trillion annually) in health and education will not close the existing funding gaps.

We highlight the underinvestment in tackling global health challenges. Underinvestment in health can worsen health disparities, disproportionately impacting vulnerable and marginalised populations. We must tap into the networks of investors to identify new sustainable financing structures for health. This could promote investments into health systems and innovations that can be scaled up to minimise global health and health system funding gaps.

Lessons learnt from COVID-19

Based on the experiences of dealing with previous pandemics and COVID-19, we raise awareness among policymakers that the future of global health should no longer be seen as disaster relief and that

sustainable financing solutions must be found and implemented – shifting from a reactive to a proactive approach. Innovative models are promoted and presented to G20 & G7 Health and Finance Ministers and G20 & G7 Heads of State.

As the G20 & G7 continue to focus on areas of global health security and health system strengthening, we add value to these campaigns and drive political support for issues such as pandemic preparedness, antimicrobial resistance, and non-communicable diseases. We see technological innovations creating a new era of E-health and the role of patients and health workers that will form the central idea of our work in mobilizing political support to achieve Universal Health Coverage by 2030. We achieve this by breaking down barriers.

Through recognising health as an investment and not as a cost, we can engage the global health and financing communities in discussions about the opportunities and challenges in the application of current and new sustainable financing models for health. Our objective is to look at outcome-oriented solutions with our partners to help increase fiscal resources for health expenditure.

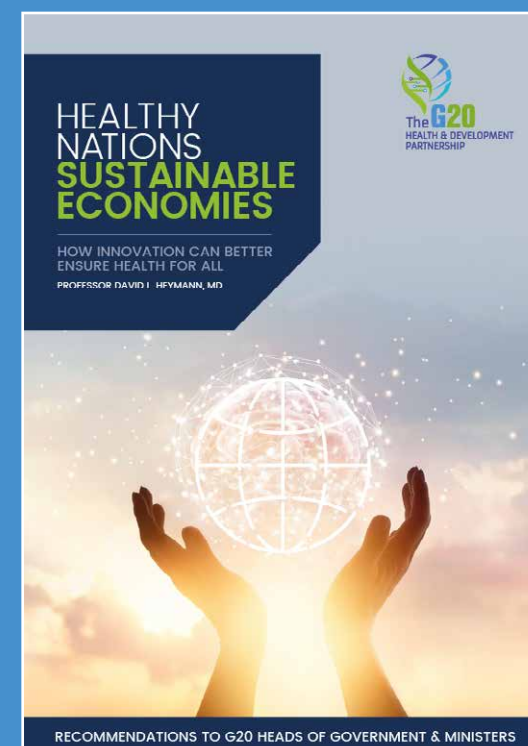
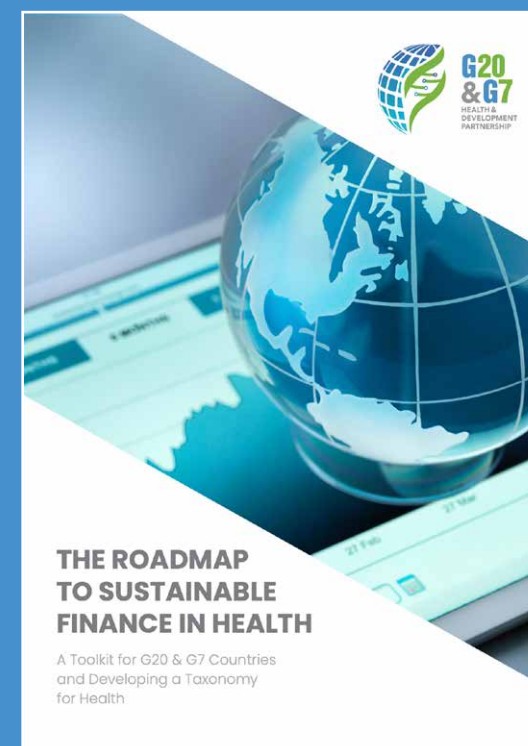

Annually we host a Health20 Summit, which was held this year at the United Nations in Geneva where we had in depth discussions on how to turn G20 and G7 recommendations into concrete policy recommendations. Together with over 60+ speakers including G20 and G7 policymakers, politicians, international organisations, the global health community, economists and investors, we discussed that public health must not fade away from global and national political debates and that we need to create more cohesiveness between the G20 and G7 Presidencies.

Parliamentary Council

Council Members

The G20 & G7 Health and Development Partnership's Parliamentary Council

The Council was launched in September 2021 at the annual H20 Summit. The Council was formed in response to the emerging challenges from the COVID-19 pandemic to tackle the disconnect that existed between governments, parliaments and the private sector. It supports a more efficient and joined up response to tackle the pandemic and its socioeconomic implications. It is operated by the G20&G7 HDP and comprised of an exclusive group of cross-party parliamentarians within G20 countries. We're expanding the Council to include representatives from each G20 country.

What is the Role of the Parliamentary Council?

Parliamentarians are enlightened about global health trends and challenges to help them inform their peers and constituents. The ambition is to implement the concept of a multiannual surveillance procedure across the G20 that will ensure a regular briefing of healthcare spending and preparedness to parliaments. Parliamentarians also promote our recommendations to their national parliaments and to fellow parliamentarians.

Health-related crises have been handled in the same vein as natural disasters. The Council works to highlight the link between the economy and health, helping to view health as an investment into national economies, rather than as an expenditure.

What is the Council's relationship to the Partnership?

The Council works closely with the Secretariat of the G20&G7 HDP to help advance the key messages of the Partnership. The Secretariat provides evidence-based know-how relating to key emerging health challenges. The Council works closely with the G20&G7HDP Secretariat and its global ambassadors.

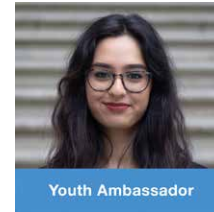

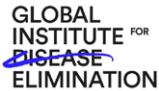
